- How to develop a comprehensive Special Needs Care Plan
- Future Care Cost Estimates
- Texas Waivers-Interest Lists
- SSI & SSDI-Understanding the differences and knowing when to apply
- ABLE Accounts
- Beneficiary Designations
- Special Needs Trusts - How to fund them - Child Support post 18 redirected to a First Party SNT
- Start touring Residential Living Facilities- waiting lists can be long
- Consider Guardianship, Alternatives to Guardianship, POA, HCPOA and Supported Decision-Making Agreement
(Guardianship process can begin 6 months before turning 18)
- Post High School Education Options
